## ACKNOWLEDGMENT OF RISKS & HAZARDS LIABILITY RELEASE & AGREEMENT NOT TO SUE

1. I understand that mountain biking, and the use of passenger tramways are HAZARDOUS ACTIVITIES. I understand that mountain biking and the use of bicycles, other equipment and lifts involves risk of injury to any and all parts of my body. I further understand that there are numerous risks and dangers inherent in the sport of mountain biking and other activities including but not limited to: the unevenness of the surface which contains rocks, bumps, ruts, stumps, tall and slippery grass or other vegetation, water bars, the steepness of the terrain, (all of which may or may not be visible) the possibility of becoming lost on the mountain, attacks by animals, insect bites or stings, collisions with other trail users, trees, poles or objects. I understand that having a Northstar at Tahoe (NAT) employee present does not lessen the amount or severity of the risks of these activities. I understand that NAT is not responsible for my safety. It is further understood that participating in mountain bike competitions and/or events may be more HAZARDOUS than recreational mountain biking. Furthermore, I understand that I must keep deliberate and conscious control of my physical body, both on the ground and in the air, while properly using my equipment in variable weather, and terrain conditions. I understand and accept that minor injuries may become life-threatening emergencies when far away from others or convenient facilities.
2. I hereby certify that I am physically fit and have no medical conditions or allergies that affect my ability to participate in these activities. **Initials: \_\_\_\_\_**

I hereby freely and expressly assume and accept the responsibility for any and all risks of injury, death or property damage while participating in these activities or related activities, or while using Releasees' facilities, equipment and premises, and I agree to RELEASE, FOREVER DISCHARGE, INDEMNIFY, DEFEND and HOLD HARMLESS Trimont Land Company, DBA Northstar at Tahoe, its parent, subsidiary, affiliated and successor companies, real and personal property owners, employees, agents, directors and officers, as well as the equipment manufacturers and distributors and all the event sponsors (hereinafter "Releasees") from all LIABILITY FOR NEGLIGENCE, and any and all losses, damages, costs and attorney's fees resulting from any and all claims or suits for personal injury, death and/or property damage that may in any way arise out of my participation in these activities, related activities, or my use of the Releasees trail system, its equipment, or any equipment, facilities and premises, hereafter "facilities", regardless of how or by whom or by what the personal injury, death and/or property damage was caused. As a condition of me, or my child, being entitled to participate in the activities at Northstar and being permitted to gain access to and use the NAT facilities, equipment and premises, I hereby promise not to bring (on my behalf, on behalf of my child or otherwise) any claim against or sue Releasees, for any reason and under all circumstances.
4. **I AGREE TO RELEASE, FOREVER DISCHARGE, INDEMNIFY, DEFEND, AND HOLD HARMLESS THE RELEASEES FROM ANY AND ALL CLAIMS, SUITS, COSTS AND ATTORNEYS FEES FOR DAMAGE AND PERSONAL INJURY TO ME OR MY PROPERTY RESULTING FROM THE NEGLIGENT ACTS OR OMISSIONS OF THE RELEASEES. I UNDERSTAND THAT THE RELEASEES ARE NOT RESPONSIBLE FOR THE CONSEQUENCES OR THEIR OWN NEGLIGENCE, THAT IS, THEIR FAILURE TO USE REASONABLE CARE IN ANY WAY.**
5. I understand that this agreement shall be binding upon my heirs, executors, administrators, and assigns and shall be governed by the applicable laws of California. I also understand that if any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. I agree that any claims, which I may bring against the Releasees, shall be submitted to the jurisdiction of the Placer County, California Courts and that no claims against the Releasees shall be brought in any other jurisdiction. I agree that there have been no warranties, expressed or implied, which have been made to me, which extend beyond the description of the equipment listed on this form.
6. I agree with the premise that a participant is a competitor at all times, whether practicing for competition or in competition. I agree that the competitor is always provided an opportunity to conduct a reasonable physical and visual inspection of the training, race or competition course, and I agree to physically and visually inspect the course before competing or training. I agree and understand that the competitor will be held to assume the risk of all course conditions including, but not limited to, weather and surface conditions, premises, course construction or layout and obstacles.
7. I consent to the use by Releasees of any pictures (video and print) for commercial purposes, or otherwise, of me in connection with the activities of Releasees, without restriction as to frequency, duration or medium.
8. I understand that permission to use NAT's equipment, trail system and premises is being given to the undersigned participant in exchange for the execution of this Liability Release and Agreement Not to Sue. I have read the above paragraphs and fully understand them. I understand that this is a RELEASE OF LIABILITY which will legally prevent me or any other person from filing suit or making any other claims for damages in the event of personal injury, death or property damage. I freely and voluntarily enter into this agreement. I have made no misrepresentations to Releasees regarding my name, age, or medical condition. I intend this document to be interpreted as broadly as permissible by California law and understand that it is not intended to assert any claims or defenses prohibited by law.
